- ❖ STP LLC may substitute another photographer to take photographs in the event of STP LLC's illness or other emergency. In the event of such substitution, STP LLC warrants that the photographer taking the photographs shall be a competent professional.
- ❖ No part of any order, including previews, will be delivered until the balance is paid in full.
- ❖ STP LLC reserves the right to use negatives, digital images and/or reproductions for advertising, display, publications or other purposes. Negatives, digital images and previews remain the exclusive property of STP LLC.
- ❖ Upon signature and receipt of a deposit of 50% of the contract total, STP LLC shall reserve the time and date agreed upon, and will not make other reservations for that time and date. For this reason all deposits are non-refundable in the final 3 calendar days prior to the session.
- ❖ If STP LLC cannot perform this contract due to fire or other casualty, strike, act of God, or other cause beyond the control of the parties, or due to STP LLC's illness or emergency, then STP LLC shall return the deposit to the client, but shall have no further liability with respect to this contract. This same limitation of liability shall also apply in the event that photographic materials are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of STP LLC. In the event that STP LLC fails to perform for any other reason, STP LLC shall not be liable for any amount in excess of the total value of this contract.
